Council Notes of September 8, 2020

Council meeting of September 8, 2020 was opened by considering issues of Justice and Righteousness from the Healthy Church materials of the CRC. Scripture readings from Matthew 25:31-40 and Isaiah 59:9-15 were read. How do we follow Jesus' mandate to "care for the least of these" in our world, which includes the poor, widow, alien, and homeless. Opening prayer by Pastor Rus. Article 1: Minutes of the August 3, 2020 council meeting were read and approved.

Article 2: Correspondence was reviewed for information. Article 3: Ministry Reports:

- Pastor's Report: Monthly report of visits, activities and mileage was received for information.
- Elder's Report: Discussion of the need to update the present church directory was held.
- Pulpit Committee: Marlyn Allspach reported that Pastor Frank Pott would be fill-in pastor for the October 4th Sunday in the absence of Pastor Rus.
- Worship Committee: KennyMeester No Report.
- Outreach Committee: Marlyn Allspach No Report
- Discipleship Committee: Mike Ascher gave information on Sunday School and Life Plus. Sunday School will begin on September 20 and continue until December, with reconsideration of the impact of the COVID 19 virus on the Sunday School at that time. Sunday School will meet on the 1st and 3rd Sundays of the month. Life Plus will be placed on "hold" for the present and efforts will be made to find ways to hold the lessons.

• Building Committee: Harold Coplen – No Report Article 4: The September 2020 financial report was presented by Mike Sterling. Receipts of <u>\$7456.49</u> were reported. The target monthly budget amount is <u>\$10,351 (for 5 Sundays in a month)</u> which resulted in a monthly shortfall of <u>\$2894.51</u> and a YTD shortfall of <u>\$6388.49</u>.

Article 5: Old Business

Article 6: New Business

- Budget discussions for next year were started. New denominational guidelines require the budget to begin at the local church level, move on to Classical level, and then on to denominational level for final budget creation. Budget plans are due in October.
- Pastor Rus proposed that two additional items be included in the next year budget. He stated that in the present budget, he had not been given dental insurance coverage or provided a life insurance policy. Dental coverage was estimated to be \$81.88 per month for the Pastor and his wife = \$983 per year. Cost for requested Life Insurance coverage (\$100,000 policy minimum) would be investigated by the Deacons and Pastor.
- The contract for the church copier was coming due on September 28. A contract for a new machine would cost \$105 per month—which is \$4 cheaper than the present contract. Motion made and adopted to purchase the new machine with Pastor Rus given the authority to sign the new contract.
- It was noted that the parking lines on the parking lot and around the church will need to be repainted. Since winter is hard on the parking lots, a decision was made to perform this project in the Spring.
